Said act was against the peace and dignity of the Commonwealth of Kentucky.

#### COUNT 7:

The Grand Jury charges that on or about September 1, 2025, in Taylor County, Kentucky, the above-named defendant failed while operating a motor vehicle, motorcycle, or moped upon a highway, secured an operator's license or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

# **COUNT 8:**

The Grand Jury charges: That on or about August 21, 2025, in Taylor County, Kentucky, the above-named defendant knowingly possessed or used any current or former identifying information of another person or family member or ancestor of the other person such as that person's or family member's or ancestor's name, address, telephone number, electronic mail address, Social Security number, driver's license number, birth date, personal identification number or code, and any other information which could be used to identify the person, including unique biometric data, with the intent to represent that he or she is the other person for the purpose of: depriving that other person of property; obtaining benefits or property to which he or she would otherwise not be entitled; making financial or credit transactions using the other person's identity; avoiding detection; or commercial or political benefit or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

#### **COUNT 2:**

The Grand Jury charges that on or about August 21, 2025, in Taylor County, Kentucky, the above-named defendant knowingly and unlawfully possessed a controlled substance that is

classified as a Schedule I or II, which is a narcotic drug; a controlled substance analogue; Methamphetamine; lysergic acid diethylamide; phencyclidine; gamma hydroxybutyric acid (GHB), including its salts, isomers, salts of isomers, and analogues; or flunitrazepam, including its salts, isomers and salts of isomers, or aided, abetted or counseled with another in said act. Said act was against the peace and dignity of the Commonwealth of Kentucky.

## **COUNT 3:**

The Grand Jury charges: That on or about August 21, 2025, in Taylor County, Kentucky, the above-named defendant knowingly and unlawfully possessed drug paraphernalia or aided, abetted or counseled with another in said act. Said act against the peace and dignity of the Commonwealth of Kentucky.
